

## **Terms of Use Agreement**

The headings to the sections this Agreement shall not affect the construction or interpretation of this Agreement.

### **ASSIGNMENT**

You agree that these Terms and Conditions and all incorporated agreements between SEORMC and You may be assigned by SEORMC, in its sole discretion.

### **WAIVER AND SEVERABILITY OF TERMS**

The failure of SEORMC to exercise or enforce any right or provision of the Terms and Conditions shall not constitute a waiver of such right or provision. If any of the provisions of this Agreement are held to be unenforceable by a court or other tribunal of competent jurisdiction, then such provisions shall be limited or eliminated to the minimum extent necessary and this Agreement shall otherwise remain in full force and effect.
